



### 2019 Picnic Pavilion Rental Form

- Rental fees are as follows: \$135 / 4-hour block OR \$80 / 2-hour block. Reservations can be made by calling the front desk at (717) 266-9294 or via email to [ckimball@legupfarm.org](mailto:ckimball@legupfarm.org). PAYMENT IS REQUIRED TO RESERVE DATE.
- Pavilion rental includes use of the playground, Music Garden and Games Garden. Two outdoor restrooms are available.
- A 20 oz. container of Koi food can be purchased for \$10. Koi food must be picked up at Leg Up Farm prior to your event. You may NOT enter the locked pond area. Koi should be fed from outside the fenced pond area.
- Renters provide food and decorations. Alcoholic beverages and portable grills are NOT allowed. Picnic tables may NOT be removed from the pavilion.
- Renters are responsible for ALL clean up. Trash receptacles are provided. Trash that does not fit should be taken. Failure to clean up will result in a \$25 cleaning fee.
- Cancellations made less than two weeks prior to event will NOT be refunded. There are NO refunds made in the event of bad weather.
